REST Tip of the Month

Reach out early! The Franklin College Research Enterprise Support Team (REST) Pre-Award team wishes to emphasize the importance of reaching out early regarding new grant proposals. REST is committed to providing comprehensive support to the diverse array of departments across the Franklin College of Arts and Sciences, comprising a total of 30 departments. Timely notifications regarding grant proposal submissions enables REST to efficiently allocate resources and offer thorough assistance in the preparation and review process for all submissions. It is imperative to note that certain grant proposals may entail exceptions to UGA policies (PI/Co-PI eligibility, cost share, export control, and indirect costs rate limitations, etc.). According to UGA SPA policy, proposals with exceptions must be prepared for submission a minimum of 10 business days in advance of the due date. Failure to adhere to these requirements may result in the inability to submit the proposal by the deadline. Again, REST urges faculty to initiate communication with the team as early as possible when considering new grant proposals. This proactive engagement ensures effective collaboration to navigate any policy exceptions and facilitates a smooth submission process.
